- Must leave buildings and grounds in clean condition. Bag your own trash and carry from park.
- **Deposit and fee must be paid at time of reservation.** No reservations will be taken over the phone unless paying with debit or credit card. Picnic shelters are rented on a first come first serve basis. Keys are to be returned by the next business day. Key Deposit will be refunded at that time.
- Picnic shelters not available for rent: Scotland Yard and Hammond Park.
